

Unique Digital Security Identifier Numbers (DSIN) linked to financial instruments information.



The price, size, timestamp, and the Market Participant ID with a provided Tick indicator.



Best Bid Best Ask

Aggregate current highest bid and lowest offer and the shares available at those prices.

Depth of Book

A real-time view of an Alternative Trading System order book for a particular security.

DORRS PRODUCTS



- Standardized digital records for companies, securities, and offerings.
- Include details such as:
 - Issuer/company information
 - Series/offering structures
 - Security type (equity, debt, digital asset security, tokenized instrument)
 - Regulatory identifiers
- Profiles link securities to directories, participants, and symbol listings.
- Designed to support market data transparency, regulatory compliance, and investor due diligence.
- · Continuously updated as issuers or assets evolve.

DORRS Network Asset Profiles

- Provide metadata on assets issued & trading on blockchain protocols connected to DORRS.
- Capture key information for each supported network:
 - Name of protocol (Ethereum, Algorand, Polygon, Avalanche, Solana, Tezos, etc.)
- Track DORRS-operated oracles that move off-chain registry data on-chain and on-chain data back off-chain.
