Overview

The Decentralized Order Reporting Registry System (DORRS) is the industry's first Financial Instrument Information Processor (FIIP) built to standardize security data, enhance transparency, and enable monetization of market data for private, digital securities and Real World Assets (RWA).

DORRS empowers Alternative Trading Systems (ATSs), Market Makers, Qualified Matching Services (QMS), Issuances, tokenization platforms and other trading venues to self-publish and distribute security information, pricing data, and transaction details through an automated, decentralized infrastructure.

Key Features & Benefits

1. Security Registry for Private & Digital Assets

- Unique Digital Security Identifiers (DSINs) for asset tracking and regulatory reporting.
- Depth of Book (DOB) & Market Data Feeds to provide real-time order book transparency.
- Best Bid & Ask Prices for price discovery and accurate liquidity insights.
- Last Sale Data with price, size, and timestamped execution history.

2. Decentralized Market Data Collection & Distribution

- Aggregates pricing and trading data from ATSs, market makers, and private issuers.
- Web portal & API integration for seamless access to market intelligence.
- Blockchain-enabled registry for secure, immutable data verification.

- Unifies fragmented security reference data across different financial ecosystems.
- Enables private ,digital securities and real world assets (RWA) interoperability between market centers.

- Subscribers: Access real-time private securities & digital asset pricing via subscription-based API & portal access.
